NAME AND PRINCIPAL OFFICE



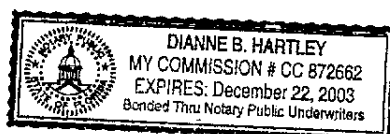
