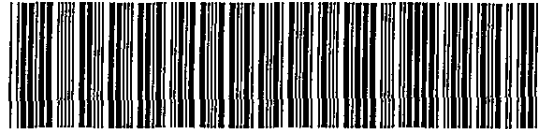

The name of the corporation is "Emotional Baggage, Inc."

**ARTICLE II**
