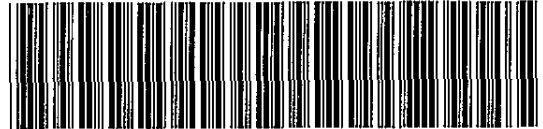


**ARTICLE IX**




