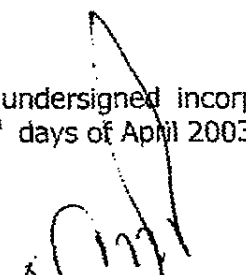
Article X – Preemptive Rights

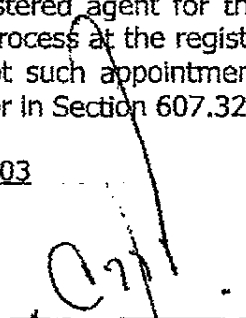
