

The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation under the laws of the State of Florida.

ARTICLE 1

NAME

The name of the Corporation is: PAREJO TRADING, INC

ARTICLE II

DURATION AND BEGINNING OF CORPORATE EXISTENCE

Parejo Trading, Inc. shall have perpetual duration from the date of filing these Articles of Incorporation.

ARTICLE III
