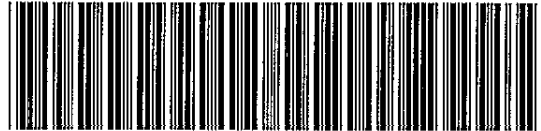

**ARTICLES OF INCORPORATION
OF
TRINITY CONCRETE PUMPING, INC.**

ARTICLE I - NAME

The name of this Corporation is Trinity Concrete Pumping, Inc. and the address is 806 East 13th Street, Apopka, Florida 32703.

ARTICLE II - TERM OF EXISTENCE

The existence of this Corporation shall exist perpetually.

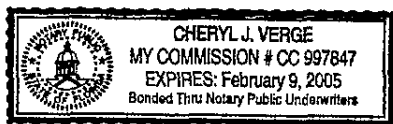
