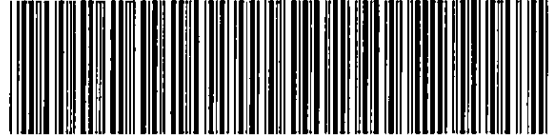

- FIRST:** The name of the Corporation is "*South Tampa Title Company.*"
