ARTICLES OF INCORPORATION

OF

NATIONAL MARINE MEDICINES RESEARCH INSTITUTE, INC.,
a Florida Corporation

ARTICLE I - NAME

The name of this corporation is National Marine Medicines Research Institute, Inc., a Florida Corporation.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated, under Chapter 607, Florida Statutes, as now exists or as may hereafter be amended.


