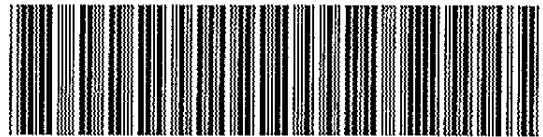

## **ARTICLE I - NAME**

The name of this corporation shall be S. P. NETWORKING, INC.

## **ARTICLE II - COMMENCEMENT & DURATION**

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Secretary of State. This corporation's duration shall be perpetual.

## **ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business as a computer networking and consulting company.

## **ARTICLE IV - CAPITAL STOCK**

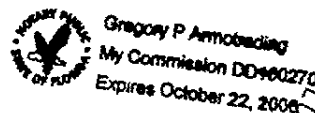
