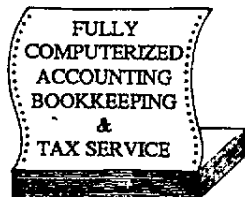

CAPITAL STOCK


The maximum number of shares which the corporation has authority to issue is 100 all of which shall be common shares with a par value of \$1.00


