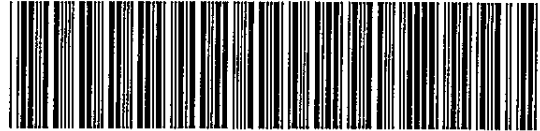

ARTICLE I
NAME

The name of this corporation is KING CAPITAL HOLDINGS, INC.

ARTICLE II
PURPOSE

To engage in mortgage brokerage business and other business permitted under the laws of the United States and the State of Florida.

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, in the manner provided by law.

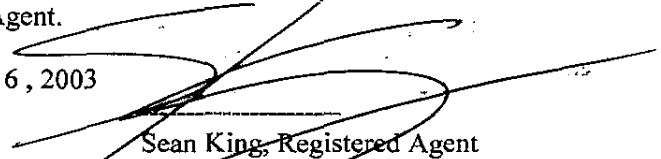
