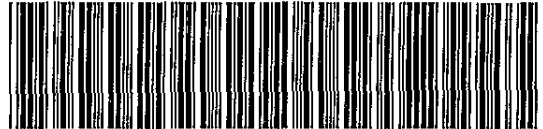

ARTICLE I - NAME

The name of this corporation is **AMERICAR MOTORS, INC.**

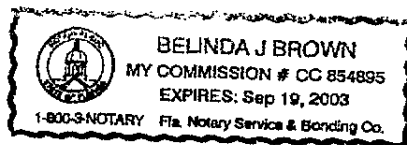

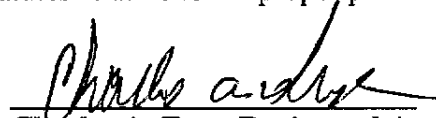
