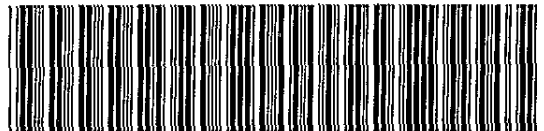

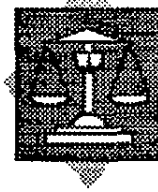

ARTICLES OF ORGANIZATION OF COCHRAN LAW, P.A.

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of organization for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Company") is COCHRAN LAW, P.A..

ARTICLE II

The existence of COCHRAN LAW, P.A., shall begin on the date of acknowledgment of these articles of incorporation.

ARTICLE III
