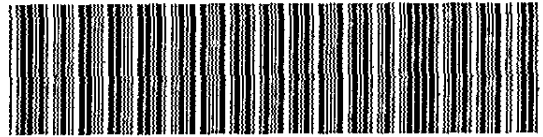

CAPITAL STOCK**

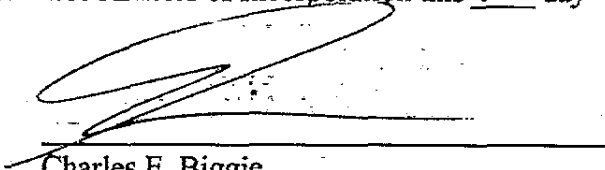

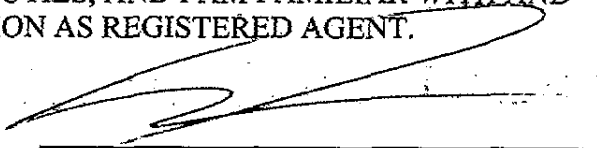
