

WE the undersigned for the purpose of becoming a Add April STATE under the laws of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of corporations for profit, file these Articles of Incorporation.

ARTICLE I

The name of the corporation is CERCOMEX MEDICAL, INC.

The general nature of the business or businesses to be transacted is as follows:


