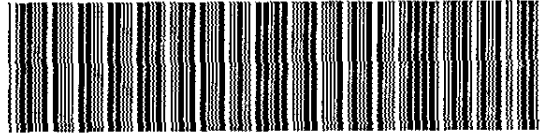

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is SILVER AGE MEDICAL SERVICES, INC.
