ARTICLES OF INCORPORATION OF VGD GP, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for VGD GP, Inc. (referred to herein as the "Corporation"):

ARTICLE I NAME

The name of the Corporation shall be VGD GP, Inc.

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal place of business of the Corporation, and the mailing address of the Corporation, shall be 2200 N.W. 84th Avenue, Miami, Florida 33178.

ARTICLE III CAPITAL STOCK

The class and number of shares of stock that the Corporation is authorized to issue is one thousand (1,000) shares of common stock, with a par value of one tenth of one cent (\$0.001) per share. Each issued and outstanding share of common stock shall be entitled to one vote per share on matters submitted to the shareholders for a vote.

ARTICLE IV REGISTERED AGENT AND ADDRESS

ARTICLE V INCORPORATOR

ARTICLE VI INDEMNIFICATION

The Corporation is authorized to indemnify the shareholders, directors, employees or agents of the Corporation to the fullest extent permitted by law.
