ARTICLES OF INCORPORATION

OF

HEALTH TEAM INSTITUTE, INC.

The undersigned Incorporator hereby forms a corporation under the Florida Business Corporation Act (Florida Statutes, Chapter 607) and hereby adopts the following:

First. Corporate Name.

The name of the Corporation (the "Corporation") is:

HEALTH TEAM INSTITUTE, INC.

Second. Mailing Address of Corporation.

The principal office of the Corporation shall be is 2770 N. E. 24th Street, Lighthouse Point, Florida 33064.

Third. Nature of Business

The general nature of the business to be transacted by the Corporation is to conduct any and all lawful activities or business permitted under the laws of the United States of America and the State of Florida (and in particular, without limitation, Chapter 607 of the Florida Statutes, entitled the Florida Business Corporation Act which is hereby incorporated by reference herein these Articles of Incorporation).

Fourth. Capital Stock.

The aggregate number of shares of stock that the Corporation is authorized to issue and have outstanding at any one time is Ten Thousand (10,000) shares of common stock having a par value of \$.01 per share.

Fifth. Term of Existence.

The Corporation shall have perpetual existence.

Eighth. Amendment.

These Articles of Incorporation may be amended in the manner prescribed by law, except that upon the issuance of shares, every amendment must be approved by the Board of Directors of the Corporation before it is submitted to the shareholders of the Corporation for their approval.

Ninth. Indemnification.

Except as may otherwise be provided in the Bylaws of the Corporation, the Corporation shall indepenity its incorporator, officers and directors to the fullest extent permitted by law either now or hereafter in effect.
