OF

THE PINK ALLIGATOR, INC.

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I-NAME

The name of the corporation ("Corporation") is THE PINK ALLIGATOR, INC.

ARTICLE II - CORPORATE DURATION

This corporation shall have perpetual existence and shall commence upon the filing of these Articles of Incorporation.

ARTICLE III - CAPITAL STOCK

The Corporation is authorized to issue one hundred (100) shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares."

ARTICLE IV - INITIAL PRINCIPAL OFFICE

ARTICLE VI - MANAGEMENT BY SHAREHOLDERS

The business of this corporation shall be managed by its shareholders rather than a Board

of Directors. In the management of the business of this corporation, the act of the shareholders

representing the majority of the outstanding shares of the corporation entitled to vote,

represented in person or by proxy, shall be the act of the shareholders, except as otherwise

provided for in any Shareholders' Agreement entered into. Each shareholder shall be entitled to

one vote in person, or by proxy, for each share of voting stock held by him. A majority of the

outstanding shares of the corporation entitled to vote, represented in person or by proxy, shall

constitute a quorum at any meeting of the shareholders for the management of the corporation

business.

ARTICLE VII - PREEMPTIVE RIGHTS

The shareholders of the Corporation shall have the preemptive right to acquire unissued

or treasury shares of the Corporation in proportion to their respective percentages of stock

ownership.

ARTICLE VIII - INDEMNIFICATION

The Corporation shall indemnify any officer or director, or any former officer or director,

to the full extent permitted by law.

ARTICLE IX - INCORPORATOR
