ARTICLES OF INCORPORATION

OF

AMELIA OCCASIONS, INC.

OS RAZS MOUSE The undersigned, for the purpose of forming a corporation under the Florid General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name and Address: The name of the corporation is Amelia Occasions, Inc., located at 5142 Sea Chase Drive, No. 1, Amelia Island, FL 32034.
 - Article 2. Duration. The duration of the Corporation is perpetual.
- Article 3. Commencement of Corporation Existence. In accordance with Section 607.167, Florida Statutes, the date when corporate existence shall commence is the date of subscription and acknowledgement of these Articles of Incorporation.
- The general purposes for which the Corporation is Purpose. Article 4. organized are the following:
 - To engage in and transfer any lawful business for which corporations may A. be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
 - To do such other things as are incidental to the purposes of the B. Corporation or necessary or desirable in order to accomplish them.
- Article 5. Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is 7,500 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

 - A. Any stock of any class that the Corporation may issue or sell, whether or not exchangeable for any stock of the Corporation of any class or classes, and whether or not of unissued shares authorized by

the Articles of Incorporation as originally filed or by the amendment thereof or out of shares of stock of the Corporation acquired by it after the issuance thereof, and whether issued for cash or other consideration; or

B. Any obligation that the Corporation may issue or sell which is convertible into or exchangeable for any stock of the Corporation of any class or classes, or to which it attached or pertinent any warrant or warrants for other instruments conferring on the holder the right to subscribe for or purchase from the Corporation any shares of its stock of any class or classes.

This right shall be deemed waived by any Shareholder who does not exercise it and pay for the shares preempted within thirty (30) days after receipt of written notice from the Corporation stating the price, terms and conditions of the issue of shares and inviting the Shareholder to exercise this preemptive right.
