ARTICLES OF INCORPORATION

OF

The undersigned subscriber, a natural person competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation shall be, Okeechobee Music, Inc.

Its principal office shall be at 909 South Parrot Avenue, Suite J-4, Okeechobee, Florida 34974 or at such other place as may be designated, from time to time, by the Board of Directors.
