The undersigned, for the purpose of forming a corporation for profit under the lawd of Thorista Jor STATE adopts the following Articles of Incorporation.

#### ARTICLE I

#### NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is Oceanfront Condominium II Developers, Inc.

Section 1.2 <u>Address</u>. The principal office and mailing address of the corporation shall be 8720 Rolling Brook Lane, Jacksonville, Florida 32256.

#### ARTICLE II

#### DURATION

Section 2.1 <u>Duration</u>. This corporation shall exist perpetually.
