**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is Murphy Business Brokers - Jacksonville, Inc., and the principal address and principal place of business is 2196 Main Street, Suite E, Dunedin, Florida 34698.

**ARTICLE II - REGISTERED OFFICE AND AGENT**

**ARTICLE III - PURPOSE**
