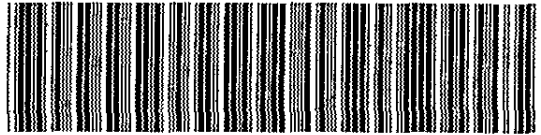

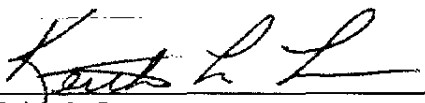
ARTICLE VI. INCORPORATOR

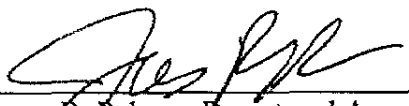
