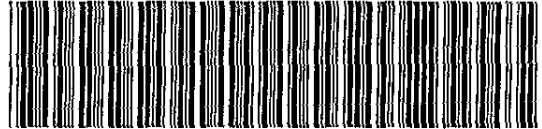

ARTICLE I. NAME

The name of this corporation shall be Robert C. Smith, P.A.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing on April 28, 2003.

ARTICLE III. PURPOSE
