ARTICLES OF INCORPORATION

OF

SHREE VINAYAK, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: SHREE VINAYAK, INC., 1290 S. Ridgewood Avenue, Daytona Beach, Florida 32114.


