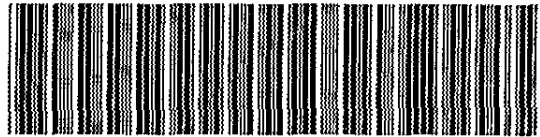

The meeting was called for the specific purpose of changing the name of the corporation as shown in Article 1 of the Articles of Incorporation.


Upon motion duly made and carried by unanimous vote, it was approved by the shareholders and directors:
