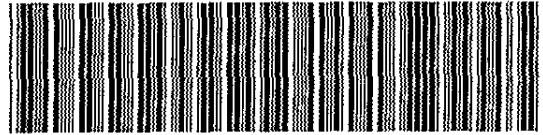

OF

Article 1. Name.

The name of the Corporation is Sebritan International, Inc.

Article 2. Duration.

The Corporation shall have perpetual duration.

Article 3. Applicable Statutes.

The Corporation is organized in compliance with Chapter 607 of the Florida Statutes.

Article 4. Purposes.

The Corporation is organized for the purpose of engaging in any activity as may be authorized by the Board of Directors and not prohibited under the laws of Florida.

Article 5. Capital Stock.

The Corporation shall have the authority, acting through its Board of Directors, to issue not more than 10,000 shares of common stock without par value.

Article 6. Board of Directors.

The affairs of the Corporation shall be governed by a Board of Directors, the number, qualification, and method of election of which shall be set in the Corporation's By-Laws. The initial Board of Directors shall consist of the following:

In addition to, but not in limitation of, the general powers conferred by law, the Corporation shall have the power, by resolution of the Board of Directors, to make distributions to its shareholders out of its capital surplus, to purchase its own share out of its own unreserved and unrestricted earned surplus, and to place restrictions upon the transfer of shares and to enter into agreements concerning such restrictions.
