**ARTICLES OF INCORPORATION**

**ARTICLE I - NAME**

The name of this corporation is JESUS AUTOMOTIVE, INC.

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 1872 Capeside Circle, Wellington, Florida 33414.

**ARTICLE III - CAPITAL STOCK**

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".

**ARTICLE IV - PRE-EMPTIVE RIGHTS**
