ARTICLE 1

Name and Duration

The name of the Corporation is Charter Insurance Agency, Inc. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

The address of the principal office of the Corporation is 851 N. Donnelly Street, Mount Dora, Florida 32757.

ARTICLE III

Registered Office and Agent

The address of the registered office in the State of Florida is 851 N. Donnelly Street, in the City of Mount Dora, County of Lake. The name of the registered agent at such address is Sheryl C. Chorvat.

ARTICLE IV

Corporate Purposes, Powers and Rights

- 1. The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.
- 2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Florida Business Corporation Act.

ARTICLE V

Capital Stock

The total number of shares of capital stock which the Corporation has the authority to issue is 1,000 shares of Common Stock ("Common Stock"), \$0.01 par value per share.

Bylaws

The power to adopt, amend or repeal bylaws for the management of this Corporation shall be vested in the Board of Directors or the statisholders, but the Board of Directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to amendment or repeal by the Board of Directors.

AKTICLE X

Independentian

The Corporation shall indemnify any incorporator, officer or director, or any former incorporator, officer or director, to the full cases permitted by law.

ARTICLE XI

Transfer of Shares

If, from time to time, a shareholders' agreement among all of the shareholders of the Corporation is in officer regarding the Subchapter S status of the Corporation pursuant to the internal Revenue Code of the United States in effect from pine to time, then transfers of the Corporation's Common Stock made not in accordance with such agreement, whether by operation of law or otherwise, are null and void ab initio.
