# **ARTICLES OF INCORPORATION**

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

### ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is <u>CHRIS'S LIGHTNING LUBE</u>, INC., hereinafter referred to as the "Corporation".
