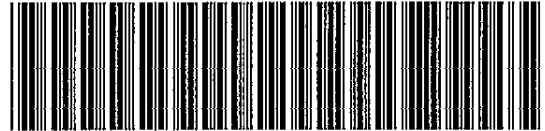

ARTICLES OF INCORPORATION

OF

SECOND: The street address of the initial principal office, and, if different, the mailing address of the corporation is 11 Ray Avenue, Burlington, MA 01803.


THIRD: The number of shares the corporation is authorized to issue is 200,000 shares of Common Stock, \$.01 par value.






