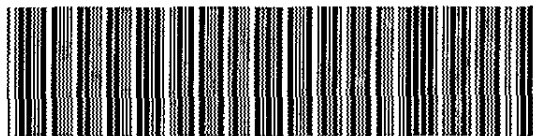

ARTICLE I

NAME

The name of the Corporation shall be:

MINORITY SYSTEMS, INC.

ARTICLE II

NATURE OF BUSINESS
