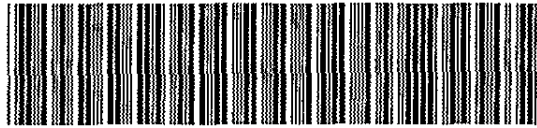

**ARTICLE I - NAME OF CORPORATION**

The name of the corporations is Padron & Padron Cleaning Services, Inc.

**ARTICLE II - DURATION**

The duration of the corporation is perpetual.

**ARTICLE III - GENERAL PURPOSE**


