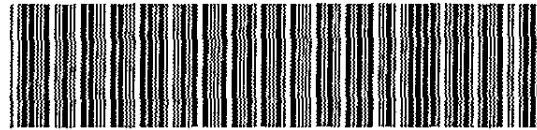

***ARTICLES OF INCORPORATION***

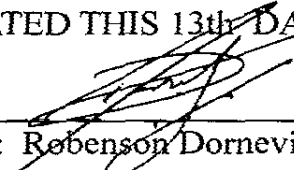
**ARTICLE IX - COMMON DIRECTORS**
