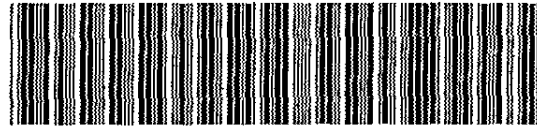

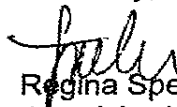

of

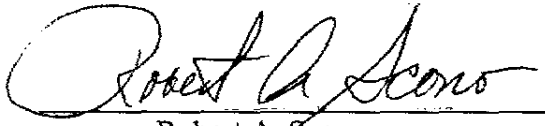
