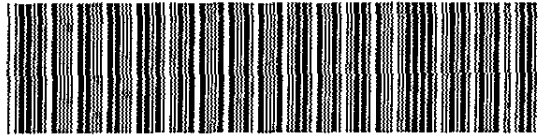

The undersigned incorporators to this Article of Incorporation hereby form a Corporation under the laws of the State of Florida as follow:

**ARTICLE I**

The name of this Corporation is Sure Foundation. The street address of the Corporation: 950 Girard Drive, Orlando, FL 32824.

**ARTICLE II**

Term of Existence

This Corporation shall have perpetual existence, commencing upon filing of these articles of incorporation with the Florida Secretary of State.

**ARTICLE III**

Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV**

Powers

The Corporation shall have the power:

- (a) To have perpetual succession by its Sure Foundation Inc.
- (b) To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced.
- (c) To make contracts and guaranties and incurs liabilities, borrow money at such rates of interest as the Corporation may determine.
- (d) To lend money for its corporate purposes, invest and reinvest its funds.
- (e) To conduct its business, carry on its operations, and have offices and exercise the powers granted by the Florida General Corporation Act within or without the State of Florida.
- (f) To make and alter bylaws, not inconsistent with these Articles of Incorporation and the laws of this state, for the administration and regulation of the affairs of the Corporation.
- (g) To have and exercise all powers necessary or convenient to affect its purposes.

**ARTICLE V**

Capital Stock

This Corporation is authorized to issue 100 shares of \$10 par value common stock, which shall be designated common shares.

## ARTICLE VI

### Initial Registered Office and Agent

### Bylaws

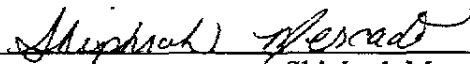
The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors of this Corporation.

These Articles of Incorporation may be amended in the manner provided by law.

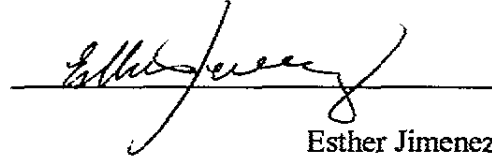
