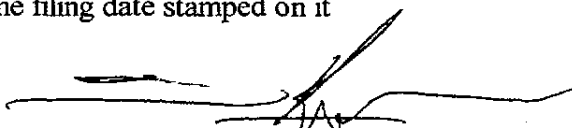

**ARTICLE 1**

**NAME**

The name of the Corporation is "ARC Manufacturing, Inc.", and its principal office and place of business shall be located at 2140 Calumet Street, Clearwater, FL 33765.

**ARTICLE II**

**CAPITAL STOCK**

The Corporation shall have the authority, acting by its Board of Directors, to issue not more than 1,000 shares of no par value common stock.

**ARTICLE III**

**REGISTERED AGENT AND OFFICE**

The name of the initial registered agent of the corporation is Addison Randolph Crockett. The address of the initial registered office of the corporation is 2140 Calumet Street, Clearwater, FL 33765

**ARTICLE IV**

**INCORPORATOR**

**ARTICLE V**

**COMMENCEMENT OF CORPORATE EXISTENCE**

The Corporation shall commence corporate existence on the date these Articles of Incorporation are filed with the Florida Secretary of State and shall have perpetual duration unless sooner dissolved according to law.

## **ARTICLE VI**

### **GENERAL PURPOSE: GENERAL POWERS**

This is a for profit corporation, organized for the following purposes: to engage in any lawful act or activity for which a corporation may be organized under the Florida Business Corporation Act, as the same now exists or same may be hereafter amended.
