ARTICLES OF INCORPORATION OF:

BOAT SOLUTIONS, CORP. 2000 N.E. 135th Street #810 North Miami Florida 33181

ARTICLE I - NAME

The name of this componation is: BOAT SOLUTIONS, CORP.

ARTÍCLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incorporation by the initial subscribers.

ARTICLE III - PURPOSE

<u>ARTICLE V - PREEMPTIVE RIGHTS</u>
