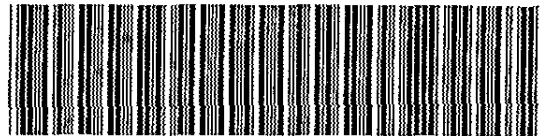



ARTICLE I - NAME

The name of this corporation is: **LAW OFFICES OF P. L. SCHWARTZ, P.A.**

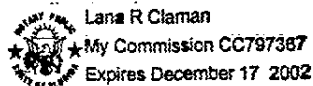
