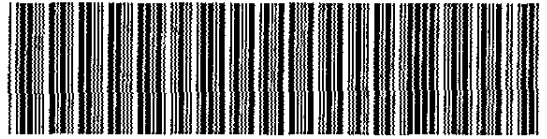

Name of Corporation






