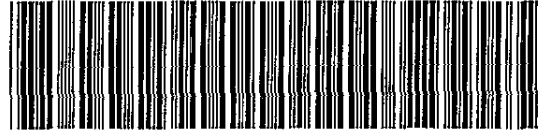

ARTICLES OF INCORPORATION OF

1. **ARTICLE I Name.**
