ARTICLE I NAME AND ADDRESS

- Section 1.1. Name. The name of the corporation is FLOE Materials, Inc.
- Section 1.2. <u>Address of Principal Office</u>. The address of the principal office of the corporation is 13709 Progress Blvd., Alachua, Florida 32615.

ARTICLE II DURATION

Section 2.1. <u>Duration</u>. This corporation shall exist perpetually. ARTICLE III PURPOSES

Section 3.1. <u>Purposes</u>. This corporation is organized for the purposes of transacting any or all lawful business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV CAPITAL
