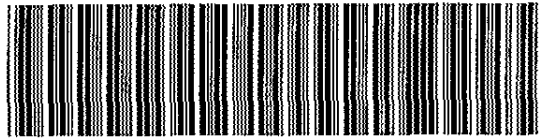

**ARTICLES OF INCORPORATION
OF
TSUS1, INC.**

The undersigned, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I
NAME OF CORPORATION**

The name of the corporation shall be **TSUS1, INC.** The address of the principal office of the corporation is 1850 Cobia Drive, Vero Beach, Florida 32960.

**ARTICLE II
PURPOSE OF BUSINESS**

The corporation is organized for the purpose of engaging in any activity permitted under the laws of the United States or of this State.

**ARTICLE III
CAPITAL STOCK**

The capital stock of this corporation shall consist of 10,000 shares of \$1.00 par value common stock, fully paid and non-assessable. 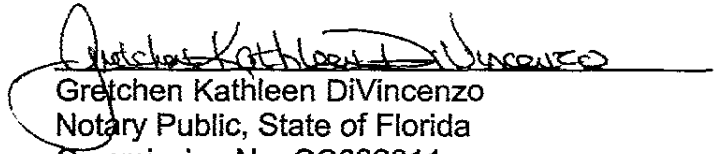

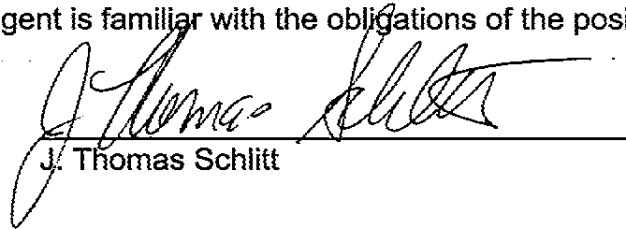
