

## ARTICLES OF INCORPORATION OF TSUS1, INC.

The undersigned, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a corporation under the laws of the State of Florida:

#### ARTICLE I NAME OF CORPORATION

The name of the corporation shall be **TSUS1**, **INC**. The address of the principal office of the corporation is 1850 Cobia Drive, Vero Beach, Florida 32960.
