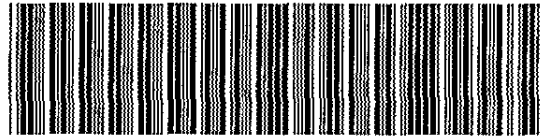

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of the corporation shall be Zenmar Enterprises, Inc. (the "Corporation"). The address of the principal office of the Corporation shall be 17215 Tiffany Shore Drive, Lutz, Florida 33549 in Hillsborough County, and the mailing address shall be the same.

ARTICLE II. CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is one hundred thousand (100,000) shares of common stock having a par value of \$0.01 per share.

ARTICLE III. INITIAL REGISTERED AGENT AND STREET ADDRESS

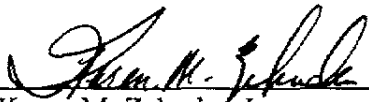

ARTICLE VII. AMENDMENT

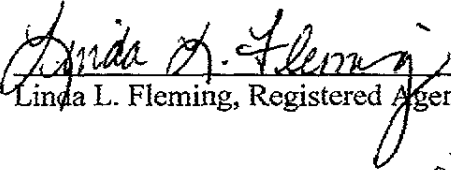
These Articles of Incorporation may be amended, modified, repealed, restated, or replaced only as set forth in the Bylaws of the Corporation.
