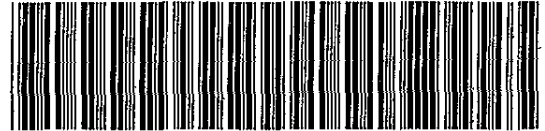



**ARTICLES OF INCORPORATION  
OF**

**FALAFEL BROTHERS, INC., a Florida Corporation**

The undersigned, acting as Incorporators for this Florida corporation hereby incorporated under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, and the undersigned hereby adopt the following Articles of Incorporation for this Corporation:

**ARTICLE I – CORPORATE NAME & ADDRESS**

The name of this Corporation is **FALAFEL BROTHERS, INC.** The mailing address for the principal office of this corporation is c/o Jeffrey R. Dollinger, One SE First Avenue, Gainesville, Florida 32601.

**ARTICLE II - PURPOSE**

The Corporation is organized for the purpose of marketing and brokering the “Falafelburger” and its related products, including the “traditional” size and “appetizer” size products. This Corporation is also organized for the purpose of manufacturing the “Falafelburger” and its related products as licensed or contractually permitted by Falafelburger, Inc. Finally, this Corporation is also organized for any lawful purpose permitted under the laws of the State of Florida and under the laws of the United States of America.

**ARTICLE III - DURATION**

The Corporation shall have perpetual existence, and shall commence existence upon signing these Articles or later if required by law.

**ARTICLE IV - AMENDMENTS**

These Articles of Incorporation can be amended at any time, upon vote of ninety percent of all shareholder votes.

**ARTICLE V - CAPITAL STOCK**

The Corporation is authorized to issue 300 shares of one dollar (\$1.00) par value Common Stock.

**ARTICLE VI - BOARD OF DIRECTORS**

The Corporation shall initially have three Directors to hold office until the first annual meeting of shareholders and until a successor(s) has been duly elected and qualified, or, if earlier, until resignation, removal from office, or death. The number of directors may be increased or decreased at any time, upon unanimous vote of all shareholders. The names and addresses of the initial directors of the Corporation are:
