ARTICLE I

Name

The name of the corporation is PURSLEY SERVICES, INC.

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

The general nature of the business to be conducted and transacted by this Corporation is any lawful business.






