The name of this corporation is Tactical Ocean Data, Inc.

OFFICERS AND DIRECTORS**

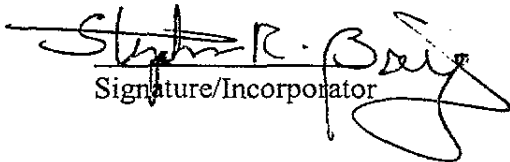
Every Officer and every Director of the corporation shall be indemnified by the corporation, as permitted by law, against all expenses and liability, including counsel fees, and all fees reasonably

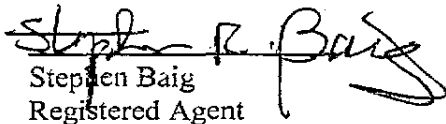
