under the Florida Business Corporation Act, hereby adopt the following Articles of  
Incorporation.

ARTICLE I: NAME

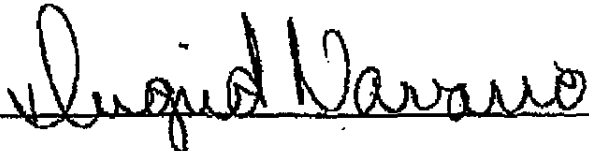
